# **Privacy Notice**

#### Why we collect your personal information

Under the Personal Information Protection Act 2004 (Tas) and as a registered training organisation (RTO 45602), we collect your personal information so we can process and manage your enrolment in a vocational education and training (VET) course with us.

If you do not provide the required personal information Gowrie Training and Consultancy (RTO 45602) is not able to enrol you as a learner.

Gowrie Training & Consultancy is a custodian of personal information and subject to the requirements of that Act in regard to the collection, use and disclosure of personal information. Gowrie Training & Consultancy collects your personal information in order to enable it to perform its functions and activities

Your personal information (including the personal information contained in the application for enrolment form and your training activity data) may be used or disclosed by Gowrie Training & Consultancy for statistical, administrative, regulatory and research purposes. Gowrie Training & Consultancy may disclose your personal information for these purposes to third parties, including:

- School if you are a secondary student undertaking VET, including a school-based apprenticeship or traineeship;
- Employer if you are enrolled in training paid by your employer;
- Commonwealth and State or Territory government departments and authorised agencies;
- Organisations conducting research on behalf of Gowrie Training & Consultancy.

#### How we use your personal information

We use your personal information to enable us to deliver VET courses to you, and otherwise, as needed, to comply with our obligations as an RTO.

## How we disclose your personal information

We are required by law (under the *National Vocational Education and Training Regulator Act 2011* (Cth) (NVETR Act)) to disclose the personal information we collect about you to the National VET Data Collection kept by the National Centre for Vocational Education Research Ltd (NCVER). The NCVER is responsible for collecting, managing, analysing and communicating research and statistics about the Australian VET sector.

We are also authorised by law (under the NVETR Act) to disclose your personal information to the relevant state or territory training authority.

# How the NCVER and other bodies handle your personal information

The NCVER will collect, hold, use and disclose your personal information in accordance with the law, including the *Privacy Act 1988* (Cth) (Privacy Act) and the NVETR Act. Your personal information may be used and disclosed by NCVER for purposes that include populating authenticated VET transcripts; administration of VET; facilitation of statistics and research relating to education, including surveys and data linkage; and understanding the VET market.

The NCVER is authorised to disclose information to the Australian Government Department of Employment and Workplace Relations (DEWR), Commonwealth authorities, State and Territory authorities (other than registered training organisations) that deal with matters relating to VET and VET regulators for the purposes of those bodies, including to enable:

- administration of VET, including program administration, regulation, monitoring and evaluation
- facilitation of statistics and research relating to education, including surveys and data linkage
- understanding how the VET market operates, for policy, workforce planning and consumer information.

The NCVER may also disclose personal information to persons engaged by NCVER to conduct research on NCVER's behalf.

The NCVER does not intend to disclose your personal information to any overseas recipients.
